MESSAGE

On 11/1/09 at 1:07 am Rockford Police responded to 814 Kilburn regarding a shooting investigation. On arrival Officers located (3) victims that were still on scene that had been shot while attending a Halloween Party. **Nathan Melendez- Torrance (19 years of age)**, and **DeAngelo Link (16 years of age)** had been shot and later died at a local hospital. An 18 year old female, and 18 year old male who was later located at a hospital were also shot but sustained non life threatening injuries.

An extensive investigation was conducted by Rockford Police Detectives and reviewed by the Winnebago County States Attorneys Office. The following subjects had been in custody for unrelated charges have now been served with Murder Warrants:
