MESSAGE

On 10/28/09 at 1:50pm Rockford Police responded to 6100 Garrett Lane regarding an Aggravated Discharge incident. On arrival Officers learned the suspect had left and were obtaining suspect information when an Armed Robbery with a gun at Blockbuster Video 6430 East State was reported. Officers were able to determine the suspect description of the armed robbery was the same as the person that committed the aggravated discharge on Garrett Lane.

While Officers were at Garrett the suspect from the Aggravated Discharge and Armed Robbery returned but upon observing Officers fled on foot abandoning his auto. Additional Officers and Detectives arrived and set up a perimeter of the immediate area.

Kevin J Cybul (41 years of age) was taken into custody by Detectives and Officers in the 6100 block of Garrett without incident. The case facts were reviewed with the Winnebago County States Attorneys Office who authorized charges of Armed Robbery. Further follow up is being conducted and no picture is available at this time.

Cybul is presumed innocent until proven guilty
