Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)

This could be an overview that includes major initiatives and highlights that were proposed and executed throughout the program year.

City Response:

The Consolidated Annual Performance and Evaluation Report (CAPER) is the City of Rockford's (City's) annual performance report for Community Planning and Development Program (CPD) dollars received through the Department of Housing and Urban Development (HUD) for programming within the municipal boundaries of the City of Rockford. CPD dollars include Community Development Block Grant (CDBG) dollars, Home Investment Partnerships Program (HOME) funds, and funding made available through the Emergency Solutions Grant. Besides reporting on 2021 accomplishments, the CAPER describes how the City is progressing to meet its goals as specified in its Consolidated Plan. The reporting period is from January 1, 2021 to December 31, 2021 – the second year of the City's 2020-2024 Consolidated Plan.

CPD programs are administered through City's Community and Economic Development Department and Health and Human Services Department. In addition, the City collaborates with other City departments, other governmental agencies, and private organizations to expend its funds.

The City's 2020-2024 Consolidated Plan identified six priorities: Housing, Homeless, Other Special Needs, Community Development, Economic Development and Administration/Planning/Management. All of these strategies are identified as a high priority, except for Other Special Needs, which is considered a low priority. All funded activities served primarily low/moderate income persons by supporting housing needs, providing needed services, improving the quality of life for individuals and households in Rockford, and continuing address the needs of underserved populations.

As in past years under the Plan, there continued to be an emphasis on the health of the City through the implementation of programs that address housing and neighborhoods. As a result, the City continued to focus on: housing rehabilitation, homeownership opportunities, the demolition of blighted properties, and to end homelessness. In 2020, the City received additional funding through the CARES Act to prevent, prepare for and respond to coronavirus. These funds continued to be primarily focused on assisting microenterprise businesses who were impacted by the pandemic (CDBG-CV) and, providing rental assistance (ESG-CV). In addition, late 2021, HUD selected the City, and City Council approved for the City, to receive \$3,579,012 in HOME – American Rescue Plan (HOME-ARP) grant funds. Planning for the HOME-ARP funds will begin during 2022.

Housing programs were made available to low (at or below 80% area median income) income homebuyers and/or homeowners. Housing rehabilitation programs addressed code and potential code violations, made homes more energy efficient, and provided for accessibility modifications for people with disabilities. In addition, the City continued to demolish dilapidated buildings and implement tactics identified under a report delivered by the Center for Community Progress.

CPD Program funds were used to address priorities and needs identified in the Consolidated Plan. A summary of the expenditures are as follows:

- 2021 CDBG funds expended in 2021, including PI, totaled \$174,384.66. The total of all CDBG expenditures (includes PI), regardless of funding year was \$1,584,891.09.
- 2021 HOME funds expended in 2021 totaled \$0. The total of all HOME expenditures, regardless of funding year in 2021 was, \$220,858.64. No PI was expended.
- 2021 ESG funds expended in 2021 totaled \$0. The total of all ESG expenditures, regardless of the funding year in 2021 was, \$50,947.56.

CDBG and HOME - Summary of Accomplishments:

- 53 substandard units were demolished
- 17 microenterprise businesses assisted with CDBG-CV funds
- 13 properties owned by low income homeowners were rehabilitated (7 with CDBG funds and 6 with HOME funds)
- 2 low income homebuyers were provided homebuyer assistance to purchase a home

In addition to the Microenterprise program, a hospitality grant program funded by the Illinois Department of Commerce & Economic Opportunity (DCEO) was also available to restaurant owners in the city to provide assistance in the form of small grants. Funding was determined by the amount of loss the business reported for the period. In 2021, \$404,913.12 was distributed to businesses via the Hospitality grant. 36 restaurant/bar businesses were assisted.

ESG – Summary of Accomplishments:

- 94 households were placed in non-congregate shelter until the City could move them into other permanent housing, including use of Emergency Housing Vouchers (EHV) and mainstream vouchers, as well as other forms of rental assistance.
- 35 households were housed with ESG Prevention.
- 80 households were housed with rapid rehousing, far exceeding a target of 45 households.
- 47 households were also assisted through outreach services.

The City of Rockford has the goal of ending all homelessness by the end of 2022, with the current focus being on homeless youth and families. ESG and ESG-CV funds were used toward this goal. Through this funding, increased street outreach was conducted in an effort to locate persons experiencing unsheltered homelessness and to connect them with services. Those on the streets who were not appropriate for shelters were placed in non-congregate emergency shelters for the winter months to prevent winter fatalities. In addition, many homeless households were placed into the Rapid-Rehousing program to get them housed and off the streets. Caseworkers then worked with them to help them obtain other housing resources. While some households remained in the program for several months (and others are still in the programs), other households were able to find other long term/permanent housing options and transitioned into those placements.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

City Response:

Please note that although the City's program year is January – December 2021, grant agreements were executed in August 2021. Most of the activities that were initiated or completed in calendar year 2021 were funded with prior program year funds. In addition, COVID affected the City's ability to administer programs, due to public health requirements of social distancing, as well as a re-prioritization of efforts to manage and administer CARES Act funding through CDBG and ESG.

2020 CDBG administrative and project delivery funds, as well as 2020 HOME Administrative funds remaining at the end of the 2020 fiscal year were carried over to 2021 to cover staff costs. The City met the 20% administrative caps. See the PR26 report included as part of this CAPER.

2021 was the second year of Rockford's 2020-2024 Consolidated Plan, which identified six priorities: Housing, Homeless, Other Special Needs, Community Development, Economic Development, and Administration/Planning/Management strategies. The Consolidated Planning process allows for these needs to either be categorized as High or Low. Based on community input during the Consolidated Plan process, as well as prioritization of limited resources, the needs of Housing, Homeless, Community Development, Economic Development, and Administration/Planning Management were identified as High Priority. It is expected that the City will fund these high priority needs during the five-year plan. Other Special Needs strategy was assigned as a low priority need. These types of activities may not be funded during the Consolidated Plan, but the City may support applications or Certificates of Consistency for other funding if the activities are consistent with identified needs. In 2021, no funds were allocated or expended for Other Special Needs.

The Housing, Community Development, Economic Development and Administration/Planning Management priorities were all supported in 2021 with CDBG funds. CDBG programs/projects included housing rehabilitation, fair housing, project delivery, demolitions, economic development, and CDBG Administration. In addition, the unanticipated CDBG-CV CARES Act funding supported additional economic development activities.

Housing:

- Seven (7) CDBG funded properties were completed. This was 18% of the annual goal, which was 40 units. Of those seven properties, seven of them were assisted through the 2021 CDBG Roof Program.
- Eight (8) HOME funded housing activities were completed. This consisted of two homebuyer activities and six homeowner rehabilitation activities.

Community Development:

- Fifty-three (53) units were demolished using CDBG funding. State and local funds allowed for an additional 18 units to be demolished (nine – local general fund & nine – Illinois Housing Development Authority Strong Communities Program grant). Therefore, a total of 71 units were demolished during 2021.
- Although City Council did not approve until January 2022, the public comment period for a substantial amendment took place during the City's 2021 fiscal year. This amendment re-allocated \$625,000 in CDBG funds from Housing Rehabilitation and \$125,000 in CDBG Economic Development funds to Infrastructure for the 9th Street Infrastructure Project that will take place during 2022.

Economic Development:

In 2020, the City was awarded Cares Act funding in the form of CDBG-CV. The City developed a Microenterprise Program, a program designed to assist small businesses with five or fewer employees (including the owner) who were negatively affected by COVID-19. The City has \$1,982,817.60 available to assist Microenterprise Businesses directly. Therefore, a total of 79 Microenterprise Businesses may be provided \$25,000 before the 6-year performance period expires. In 2021, Economic Development completed rounds four and five of the Microenterprise program, assisting 17 additional small businesses, making the cumulative total 68. Of those businesses, 13 were minority-owned and five were women-owned. The majority of the businesses assisted were those from the 3rd and 11th wards, which both have a poverty rate of 28.29% and 44.17% respectively. These numbers are important as they show the positive impact that the funds have on these businesses to keep them open and provide jobs for individuals in those areas. Although Table 1 above includes the number of CDBG-CV activities completed under EDS-2 Development, it does not include the goal of 79. This is because the City was required to complete a Substantial Amendment to its 2019 Annual Action Plan. This table includes the goals for the 2020-2024 Con Plan and 2021 Annual Action Plan, but reports on the total assisted during, regardless of the funding grant year.

Narrative

City Response:

The City utilizes CDBG dollars for project delivery of HOME and CDBG funded rehabilitation activities. Therefore, HOME funded rehabilitation activities are counted once under each program, HOME and CDBG.

71% of the seven households funded through CDBG rehabilitation activities were white, and 29% were Black/African American. 14% of the 7 households were Hispanic or Latino. According to the 2020 American Community Survey 1-Year Estimate provided by the U.S. Census Bureau, the demographic minority make up of Rockford is 29.6%. 43% of households assisted in 2021 were minorities.

50% of the eight households funded through HOME rehabilitation activities were Black/African American, and 50 % were White. According to the 2020 American Community Survey 1-Year Estimate provided by the U.S. Census Bureau, the demographic minority make up of Rockford is 29.6%. 50% of households assisted in 2021 were minorities.

Narrative

City Response:

In Table 3, the “Resources Made Available” is the amount of the 2021 award, including budgeted program income. The amount does not include any prior year grants with funding available during 2020. The “Amount Expended During the Program Year” includes all expenditures regardless of the funding year. As mentioned previously, the City did not receive its 2021 funding until August 2021. Please see section CR-05 for a summary of accomplishments and CR-45 for challenges.

The City was awarded \$1,277,632 in round one CDBG-CV and \$1,001,397 in round three CDBG-CV funds for a total award amount of \$2,279,029. The City was also awarded \$636,693.00 in round one ESG-CV funding, with an additional funding award of \$1,157,575. The \$1,001,397 in round three CDBG-CV funds and additional \$1,157,575 of ESG-CV announced in 2020 was made available during 2021. The total amount of ESG-CV funding expended during the 2021 Program Year was \$288,370. The total amount of CDBG-CV funds expended during the 2021 Program Year was \$284,328.72, making the total CDBG-CV expended as of December 31, 2021 \$1,687,593.27.

Rockford is eligible to apply for Section 108 Loan Guarantee funds up to five times its current approved CDBG entitlement allocation. These funds are available to any organization who submits an eligible project that is underwritten, meets the Section 108 loan requirements, and is ultimately approved by City Council. There were no new Section 108 projects in 2021.

In Table 4, the “Actual Percentage of Allocation” is the percentage of all 2021 CDBG and HOME obligations (executed agreements/contracts), regardless of the funding year, associated with actual projects and/or activities (e.g., demolition, housing rehabilitation project, etc.). It does not include project delivery for housing projects/activity. However, it does include project delivery for demolitions.

In 2021, the City obligated a total of \$971,640.25 in CDBG funds, \$962,353.56 of which was obligated on projects/activities located within the CDBG Eligible Area. Therefore, 99% of the City’s CDBG obligations during 2021 were located within the CDBG Eligible Areas. Of that 99%, 7% (\$66,022.33) was obligated in the City’s NRSA.

In 2021, the City received \$12,465.73 in CDBG program income (PI), which was expended on CDBG eligible activities.

In 2021, the City obligated a total of \$56,089.89 in HOME funds, \$30,568.89 of which was obligated on projects/activities located within the CDBG Eligible Area. Therefore, 54% of the City’s HOME obligations during 2021 were located within the CDBG Eligible Area.

During 2021, the City received \$15,456.26 in HOME PI. See Table 7. HOME PI received during a given year is made available to fund projects/activities during the following year. Therefore, the City’s 2022 HOME budget will include this PI of \$15,456.26.

The City received \$254,661.50 in Section 108 income during 2021. These restricted dollars are not eligible to utilize for new projects until the Section 108 obligation has been met.

Leveraging

City Response:

CDBG

The City administers a demolition program, which utilizes various funding sources including CDBG, the City's General Fund, and Illinois Housing Development Authority (IHDA) grants. In 2020, the City applied for and was awarded \$250,000 through IHDA's Strong Communities Program to demolish substandard properties. During 2021, \$100,133.86 was expended; making the total of this grant expended as of December 31, 2021, \$100,133.86. The City applied for and was awarded another \$75,000 IHDA grant to demolish substandard residential properties. The City anticipates funding to be received in 2022. In addition, the City had a \$365,228 demolition budget from the General Fund to assist with demolitions, as well.

Illinois State Statute allows the City to use a "fast track" process to demolish properties, which does not require City ownership. Once a demolition is complete, a lien is recorded on the property for the total cost, plus an administration fee. These liens are rarely paid off, but if the lien is paid off for a CDBG-funded demolition, the funds are receipted as CDBG program income. The City's Legal Department may foreclose upon a lien in limited cases, but usually with a re-use in mind. No real property was acquired using CDBG funds in 2021 by foreclosure or voluntary sale.

The Illinois Housing Development Authority's Single Family Rehabilitation Round 3 Roof Only Grant supplemented the City's CDBG funded housing programs. Approximately \$64,037.13 leveraged seven (7) completed CDBG activities.

The City was awarded \$900,000 through the Illinois Department of Commerce & Economic Opportunity (DCEO). The City expended \$404,913.12 of this grant during 2021. The purpose of the grant is to assist in establishing the Rockford Restaurant and Bar Stabilization Fund, and to distribute sub awards/grants to restaurants and bars, based on merit criteria, for losses (versus the comparable time frame for the baseline year of 2019) of average monthly revenue between April 1 and August 31, 2020.

No publicly owned land or properties were identified to address needs in its 2021 Annual Action Plan, nor was CDBG used to acquire any properties in 2021.

HOME

\$170,237.20 was expended on the eight HOME activities completed by 2021 year end, leveraging \$188,381.32 of private funds. This 111% of leverage was generated through private first mortgage lender financing, other downpayment assistance (such as IHDA and Federal Home Loan Bank of Chicago), closing credits, and owner contributions.

HOME leverage tends to fluctuate from year to year. The leverage in 2021 increased from 2020 and it is anticipated to continue to increase next year for several reasons:

1. The City's homebuyer program generates leverage with every household assisted. In 2022, the City intends to seek additional participating lenders, promote workshops and/or distribute program information via social media outlets more often.
2. Generally a significant amount of leverage is not generated by the City's housing rehabilitation program unless the City received a grant to supplement the City's rehab program, or the City executes agreements at the same time as another housing partner such as NW HomeStart, the Winnebago County Health Department, or another City department. The City will continue to collaborate with housing partners in 2022.
3. Larger rental developments and/or single-family housing developments provide leverage. The City has been working with a developer on a multi-family project that is anticipated to close in 2022. In addition, the City continues to encourage non-profit (potential Community Housing Development Organizations - CHDO) to use CHDO Reserves.

Table 5 demonstrates that the City had a Match contribution of \$39,225 during 2021, and the 2021 HOME Match liability was \$0.

ESG:

The Continuum leverages ESG and ESG CV in a number of ways including other federal, state and local funds. Community Services Block Grants funds are leveraged as match for ESG. Illinois Department of Human Services Homeless prevention funds have been used as gap or deposit funds for ESG and ESG CARES as well as local foundation funds. In addition, federal Treasury Emergency Rental Assistance (ERAP) funds have been used in place of ESG CARES prevention when possible to extend the ability to utilize ESG.

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

City Response:

CDBG & HOME:

See Section CR-05 for CDBG and HOME for differences between goals and outcomes. See Section CR-45 for problems encountered in meeting the goals.

ESG:

According to the 2021 Annual Action Plan, the goals were as follows: ESG through essential services, operating/rehab of emergency shelters, and homeless prevention/rapid rehousing, 150 homeless households will receive support, and 45 households will receive rental assistance. These goals for ESG and ESG CV were focused on reducing exposure to COVID through placing non-sheltered persons and persons who had to leave shelters due to COVID related capacity restrictions into non-congregate shelter (hotels). The City also utilized these funds to stabilize households through rental assistance utilizing both prevention and rapid rehousing. 94 households were placed in non-congregate shelter until they could be moved into other permanent housing including use of Emergency Housing Vouchers (EHV) and mainstream vouchers, as well as other forms of rental assistance. 85% of those who entered non-congregate shelter transitioned to permanent housing. Of the remaining 15%, most transitioned back into shelter as capacity increased or census decreased. 35 households were housed with ESG Prevention and 80 households with rapid rehousing, far exceeding the City's target of 45 households. 47 households were also assisted through outreach services.

Discuss how these outcomes will impact future annual action plans.

City Response:

See Section CR-45 for CDBG and HOME.

ESG:

Utilizing these funds for non-congregate shelter provided the City with an opportunity to recognize that this method of housing could result in good permanent housing options. In addition, the opportunity to increase outreach demonstrated to City staff how valuable more consistent outreach could be as it resulted in a number of unsheltered persons entering services and housing. The City plans to continue to support non-congregate shelter, outreach and rapid rehousing moving forward.

Narrative Information

City Response:

The City is required, as part of the CAPER, to address worst-case needs relevant to renters and rent burden. Worst-case needs are low-income (at or below 50% of the Area Median Income) renters who are not receiving rent subsidies and are paying more than half of their income on rent and/or living in severely inadequate housing. In 2021, the City assisted low-income renters and addressed inadequate housing as follows:

- ESG: Assisted homeless individuals in need of housing. This included subsidizing decent housing.
- HOME: Low-income renters could apply to the City's Homebuyer Assistance Program.
- CDBG: Job creation through economic development activities and the demolition of blighted and unsafe homes.

See TABLE 13 Supplemental Breakdown below. It provides additional details regarding income levels as it relates to homeownership and/or rental activities. Based on the City's program design, all HOME and CDBG activities meet the Section 215 requirements.

CR-25 - Homeless and Other Special Needs 91.220(d, e); 91.320(d, e); 91.520(c)

Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

City Response:

Homeless outreach to unsheltered person greatly increased throughout 2021. In November 2020, the City used ESG funds to hire a full-time outreach worker who spends most of their time doing street outreach or providing inreach to people at other agencies. Prior to this, the City tried to do outreach once a week versus daily. In addition, the City added nighttime street outreach at that time, having groups go out monthly to seek out newly homeless individuals and assess their needs. The City learned that once a month was not enough and changed it to twice a month during 2021. Moving into 2022, the City will increase out nighttime outreach and have groups going out once per week in addition to daily outreach. The City has found these changes to be helpful in gaining the trust of those living on the streets, have improved the City's ability to verify homeless status to ensure eligibility for homeless program (COC/ESG funded programs along with specialized HUD housing vouchers), and has made it easier to link clients with housing resources.

Addressing the emergency shelter and transitional housing needs of homeless persons

City Response:

Through ESG/ESG-CV funding, the City was able to address the shortage of emergency shelter beds by providing non-congregate (hotel/motel) options to people who would have otherwise remained unsheltered. While in the hotels, case management is provided to the participants to link them with needed resources and permanent housing options.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

City Response:

The Health & Human Services Department serves as the Coordinated Entry System (CES) provider for Rockford's Continuum of Care. Through this work, CES works extensively with the many low-income persons and systems that serve them. CES works closely with the local mental health facilities and health care systems. The Department has a contract with the child welfare system and works closely with youth exiting the foster care system who are likely to become homeless. Through the City's participation in the local CoC, strong partnerships were made with other local social services agencies, schools, community healthcare providers, housing providers, and employment agencies. The City is able to use these partnerships to link homeless clients with the services that they need to move forward and be successful.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

City Response:

For chronically homeless individuals and veterans, the City has long had the goal of housing them within 30 days of identification (45 days for a maximum). The City has implemented the same goals (no more than 45 days) for youth and families experiencing homelessness. For single adults, that will be the final goal also, but with that being out largest population at this time-the City continues to work on reducing the amount of time people are homeless. The City wants to get individuals and families housed and off the streets as soon as possible and connected to any services that they might need. Most families that are involved in the ESG programs have case management provided by housing advocates which intends to make the transition into permanent housing easier for them and provides ongoing follow up to help stabilize the situation and prevent them from losing their housing and becoming homeless again.

CR-30 - Public Housing 91.220(h); 91.320(j)

Actions taken to address the needs of public housing

City Response:

The Rockford Housing Authority owns and operates more than 1200 public housing units within the city of Rockford, and administers more than 1700 Housing Choice Vouchers. Most recently, disposing of 418 public housing units through HUD's Section 18 process, providing tenant protection vouchers to those displaced that were not transferred to alternate subsidized housing facilities.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

City Response:

The Rockford Housing Authority offers the Family Self Sufficiency (FSS) Program, which is a voluntary program that assists individuals in RHA public housing and/or in the Housing Choice Voucher program to gain economic independence. Participants are assisted in establishing an escrow account where savings are set aside to be used towards accomplishing their goals. A portion of the amount paid in rent is placed into this account. Upon successful graduation from the program, the savings are cashed out for the participant's use in achieving their final goals, which may include buying a home. RHA proudly served more than 130 families through the FSS program in 2021.

Actions taken to provide assistance to troubled PHAs

City Response:

The Rockford Housing Authority is not a troubled housing authority.

CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

City Response:

City of Rockford:

In 2020, the City began two major projects to ease the burden placed on property owners as a result of necessary code enforcement. During 2021, the City continued with its efforts to implement these projects. First, the City undertook the project of implementing a digital plan review process via the software ProjectDox. ProjectDox is a system that allows simultaneous review of building plans submitted to the Construction Services department for review. These plans are required for major renovations and rebuilds of commercial and multi-unit housing structures. By implementing this software, the City hopes to increase availability and decrease turnaround time on the average drawing submission. It also creates a cost savings to the person submitting the drawings to the City. Prior to the digitization of the system, an applicant would have to submit paper copies of their drawings in triplicate, incurring heavy paper costs and labor hours for transport. ProjectDox was available to constituents during 2021.

Additionally, the City continued to review its adopted building codes and the affiliated amendments. The purpose of this project is threefold: 1) Update existing codes to existing building professional standards; 2) Eliminate multiple amending ordinances which contradict existing codes; and 3) Streamline the various building codes to be as clear as possible for the reader. The City subscribes to the International Code Council's (ICC) method of denoting building codes. The last time that a code update occurred was in 2015. Since then, there have been multiple amendments to the codes located in different places among the City's various ordinances. The primary goal of the project is to adopt the ICC's 2021 Codes, but in doing that the City's personnel hope to streamline the existing codes and clarify some confusing language. The City has completed proposed amendments and anticipates final approval through City Council during 2022.

Rockford Housing Authority:

The Rockford Housing Authority (RHA) is committed to ensuring equality and opportunity to those seeking affordable housing, and that no one encounters discrimination or unconscious bias when inquiring on housing-related matters. By reviewing and updating current training platforms

for all staff on diversity, equity, and inclusion, while affirmatively furthering fair housing. RHA continues to partner with Prairie State Legal to host “Fair Housing” sessions for RHA residents, landlords, staff, and community members.

During 2021, RHA continued to host LifeForce Development Institute (LDI) classroom sessions, through RHA’s “Launch My Future” initiative. RHA is proud to support and recommend the LifeForce Development Institute’s Job/Career Readiness Skills-based training to both RHA Clients and Residents. The LDI Curriculum addresses the foundational skill gap in the workforce with a 12-week, hands-on learning program covering Job/Career Readiness Skills meeting the community’s workforce goals.

 - Gaps in employment
 - Housing or Homeless issues
 - Long-term welfare recipient
 - Job search skills
 - Domestic violence
 - Drug and/or alcohol abuse

During 2020, RHA created and implemented a very Section III program, and training. Today, this award-winning program, continues to partner with local manufacturers, unions, and service providers, Section III qualified residents, and community members alike, have access to local jobs and training courses, through RHA’s web-based portal.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

City Response:

The City of Rockford has taken the following actions in 2021 to address obstacles to meeting the underserved needs in the community:

- Provided HOME and CDBG funds for rehabilitation of owner-occupied housing units, owned by low-moderate income households. These programs address code violations, as well as accessibility issues.
- Continued to address foreclosed and abandoned housing issues through use of a Vacant and Foreclosed Property Registry, in addition to a demolition program, funded by CDBG, Illinois Housing Development Authority (IHDA) grants, and the City's General Funds.
- The City continued to expend CDBG-CV funds, which was used to support micro-enterprise businesses that were impacted by the COVID-19 pandemic.
- In 2021, the City applied for and received a \$75,000 Strong Communities Program grant from IHDA to leverage the existing demolition program. Grant agreements will be executed in 2022.
- In 2021, the City continued to expend IHDA Single-Family Rehab-Roof program dollars, leveraging existing federal housing rehabilitation programs. The grant expires on December 31, 2022.
- The City continues to offer a Mow-to-Own program that allows adjacent property owners to acquire City-owned vacant lots through a maintenance program. In 2021, two Mow to Own Properties were transferred to adjacent neighbors after fulfillment of the two-year maintenance agreements.
- Region 1 Planning Council (RPC) operates the Northern Illinois Land Bank Authority, which includes the City of Rockford as a voting member. In 2021, the City continued to support the efforts of RPC.
- RPC also serves as the Agent for the Winnebago County Trustee and has holds online auctions of properties. The majority of these homes will require rehabilitation work and additional investment. The trustee agent estimates that the value of these properties will be about 4x the sales price after the rehab is complete.

Health & Human Services in regards to ESG:

One barrier to affordable housing that has been identified is lack of documentation. Often times for affordable housing providers, families must provide photo identifications, social security cards, and birth certificates. ESG & ESG-CV funded staff include this as part of their services, to ensure families have all the needed documents so that they can apply for affordable housing options. The City also helps the underserved to apply for mainstream services such as SNAP or Medicaid benefits and services through the local Workforce Connection.

Rockford Housing Authority in regards to public housing:

The Rockford Housing Authority is a proud recipient of the “Jobs Plus” grant in 2021. The Jobs Plus Initiative is a free initiative aimed to help people gain higher wages and increase their income without increasing their rent – with the goal of reaching a self-sufficient living wage. The initiative will provide an employment specialist that will work one-on-one to help people reach their employment goals. In addition, the Employment Specialist will be able to provide: Employment counseling, employer linkages, job placement, and access to FREE education and training dollars for advancing their education.

Residents enrolled in Jobs Plus Initiative receive the added benefit of being eligible for the Jobs Plus Earned Income Disregard (JPEID). The JPEID benefits the resident in that it will disregard any income accumulated for up to 48 months after entering the initiative, meaning any earned income from the time of enrollment in Jobs Plus will not count toward rental certifications.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

City Response:

All of the City’s federally funded housing programs comply with the lead-based paint requirements. Community & Economic Development housing rehabilitation and homebuyer applicants receive proper notices, and properly certified people perform risk assessments, paint testing, lead hazard reduction and post project lead clearances. The City’s Rehabilitation Construction Specialist has an Illinois Department of Public Health Lead Risk Assessors License. Therefore, all required lead hazard reduction work and protective measures are incorporated into project rehabilitation specifications. Through the Health and Human Services Rapid Rehousing program, every home is inspected for lead-based paint hazards. New tenants are given proper lead-based paint notices, if the unit was built before 1978. In addition, other non-ESG housing programs administered through Health and Human Services conduct lead based paint screenings, as well.

In addition, the City has an agreement with the Winnebago County Health Department to assist with lead inspections and testing when needed. This agreement allowed experienced and licensed Health Department staff to provide these required lead-related services to the City during periods of staff transition, vacations, sick time, or workflow scheduling issues. See CR-05 for the number of housing units assisted.

Winnebago County Health Department regarding lead paint hazards:

The Winnebago County Health Department’s (WCHD) lead program works to prevent and respond to cases of childhood lead poisoning. The WCHD acts as a delegate agency for the Illinois Department of Public Health, providing case management and lead based paint risk assessments

for families affected by childhood lead poisoning. The WCHD also enforces the Illinois Lead Poisoning Prevention Code, holding property owners accountable to correct lead-based paint hazards in homes where these families live.

Additionally, the WCHD manages the “Creating Lead Safe Rockford” (CLSR) grant program funded by the Department of Housing and Urban Development (HUD) currently available to identify and correct lead hazards in qualifying households. CLSR is also able to provide a Healthy Homes Assessment, with possible remediation in qualifying households. Owner-occupied homes, rental units, and vacant properties may qualify for the CLSR program. Funds are intended to correct lead-based paint hazards and perform limited healthy homes interventions. In 2019, the WCHD was awarded more than \$3.4 million to continue the program through 2023.

In 2021, the WCHD’s lead program completed a total of 31 lead-based paint inspections/risk assessments, provided financial assistance to mitigate 31 homes, and provided case management to families of 133 children with elevated blood lead levels.

Rockford Housing Authority regarding lead paint hazards in public housing:

The Rockford Housing Authority conducts a “lead applicability review” of all projects prior to redevelopment, and reports all findings in accordance with HUD’s Annual Lead-Based paint Activity Report (2577-0090). Any target housing unit constructed prior to 1978 is assessed for lead paint hazards, and projects are completed in compliance with HUD’s Lead Safe Housing Rules and applicable standards. All lead maintenance staff are currently hold EPA lead-based paint certifications.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

City Response:

In 2021, the City of Rockford continued to utilize its CDBG-CV funds to support microenterprise and sole proprietor businesses during the COVID-19 pandemic. These funds directly assisted these business owners who were unable to access financial relief through existing resources. Funds were used to provide short-term working capital assistance to mitigate the loss of revenue resulting from the COVID-19 pandemic.

ESG & ESG-CV was able to assist some poverty-level families within Homeless Prevention program ensuring that families can remain housed when facing evictions. ESG program staff partner with other programs at the Community Action Agency to ensure those living in poverty have access to other program that can assist them. This would include utility assistance, rental assistance, scholarships, training programs, and other emergency programs.

Rockford Housing Authority regarding actions taken to reduce the number of poverty-level families in public housing:

RHA has a very robust, FSS, Ross, and RSS, and Section III, Jobs Plus, and LDI program. Through these programs, RHA partners with sixty-one community agencies to deliver services and educational programming to RHA residents. Through these programs, RHA is able to provide residents, and community members alike, with individual needs being addressed.

1. Employment-Related Service: RHA offers employment-related services to residents with a range of employment needs. This includes services such as work-readiness training, employer linkages, financial counseling, educational advancement, job placement, and employment counseling.
2. Financial incentives: Targeted residents enrolled in Jobs Plus will be granted a 100 percent income disregard that will remain in place for up to 48 months.
3. Community support for work: RHA Jobs Plus services and financial incentives to all targeted residents in a development. The goal is to saturate communities with work-related messages and to create a culture of work.

The Rockford Housing Authority has an award winning Section III program targeting employment opportunities for those that are low & very low-income. Partnering with local manufactures, unions, and service provider's, Section III qualified resident's, and community members alike, have access to local jobs and training courses, through RHA's web-based portal, and partnerships, RHA has not only met HUD expectations for employing those within the targeted income levels, but has far exceeded the required percentages.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

City Response:

To effectively implement the Five-Year Consolidated Plan, the City needs to collaborate with a variety of agencies located in the City of Rockford and in Winnebago County. Coordination and collaboration between agencies is important to ensuring that the priorities identified in the Five-Year Consolidated Plan and Annual Action Plans within the City are adequately addressed. Listed below are some key agencies and additional resources that helped to develop institutional support.

Public Institutions –

- Opportunities to collaborate with other partners on housing rehabilitation programs continued to be limited in 2021 as agency resources were prioritized to address the impact of COVID-19 on the community. The City's CEDD staff will continue to seek ways to partner and leverage available resources with such agencies as the Winnebago County Health Department's (WCHD) Lead Safe Program and the City's Weatherization program, run through the Health and Human Services Department.
- In early 2019, the City of Rockford signed an intergovernmental agreement with the City of Belvidere, and Winnebago and Boone Counties to establish the Northern Illinois Land Bank Authority (NILBA). The NILBA is operated by the Region 1 Planning Council (RPC).
- RPC was also appointed as the agent for the Winnebago County Trustee in late 2019. As a result, changes have been made to the trustee program, which include funding for maintenance, interest dollars reinvested in local properties, a modernized sales system to sell these trustee-owned properties, and municipal input on Trustee property sales.
- In 2021, the City's Neighborhood Specialist continued to facilitate networks of neighborhood associations, build capacity of organizations and community leaders, and strategize neighborhood level plans that align efforts of community organization and stakeholders with City programs. Planned programming and outreach were again limited in 2021 due to the pandemic, however, the Neighborhood Specialist continued to engage neighborhood leaders, residents and other community partners through virtual communication methods. Some highlights include the following:
 - Developing and launching Connect Rockford to provide the framework to help neighbors feel consistently supported, cared for, seen, and heard.
 - Door to Door outreach for over 17 projects and/or events
 - Participated in Cherry Valley Elementary Mobile Block Party and Nashold Fall Festival.
 - Assisted four Neighborhoods holding special events.
 - Participated as a Leader/Member for various organizations such as Rockford Area Habitat for Humanity, Alignment USA Team Leaders Cohort, National leaders Network for Socially Connected Communities.
- The City is utilizing the Neighborhood Revitalization Strategy to determine geographic priorities for community development and housing programs, depending upon the type of neighborhood (Strong, Middle, or Emerging), and the program type (i.e., homeownership, rehabilitation, economic development). This strategy was used to determine potential properties for a demolition grant application through IHDA in early 2021.
- The City's Community and Economic Development Department staff continues to seek out and apply for additional grants to partner and complement the CPD grants. In 2021, the City was awarded \$75,000 in an Illinois Housing Development Authority grant to assist with residential demolitions.
- The City's Health & Human Services Department is constantly analyzing the inflow of homelessness into the Coordinated Entry System trying to determine where the homeless population is coming from, what types of causes are bringing them into homelessness, and what type of housing or services are needed to alleviate their homeless situation and reduce the City's overall homeless population. The Department continues to work with Community Solutions/Built for Zero technical advisors to reach the federal benchmarks and

continue to build a better system for ending homelessness. Late in 2021, the department started to meet with other stakeholders around a gap in services around mental health services for the homeless population. The City found this to be a huge gap in the homeless structure and has been working with other City departments including Police, Fire, and Code Enforcement in addition to community partners such as the City's main provider of mental health services, Rockford's community health organization, and Rockford's local Township office. This group is looking for ways to bridge these gaps, get the most vulnerable and mentally ill persons off the streets and successfully housed with wrap around services so that they can be successful and not return to the streets.

- The Rockford Housing Authority continues the utilization of its Section 3 platform that includes contractor and business partnerships. RHA has developed an education, training, and job readiness program that allows contractors and businesses alike, to post and advertise job opportunities through RHA's Section 3 portal. Utilizing this portal, Section 3 qualified residents can apply for open positions and receive on the job training and education.
- RHA changed their approach to affordable housing. RHA focuses on the success of their residents, and provides the necessary tools for individuals and families to obtain and maintain self-sufficiency. RHA partners with local agencies to assist with support services to overcome barriers, and provide opportunities that would not have been otherwise available.

Private Industry –

- The City continues to partner with financial institutions who provide first-time mortgage financing for homebuyers who are interested in using the City's homebuyer assistance program funds.
- In 2021, the City's Community and Economic Development Director and Economic Development and Diversity Procurement Coordinator met with many local and state partners and organizations to discuss the impact of COVID-19 on local businesses. They worked together to identify and distribute available resources and information to assist businesses in making decisions during the Covid pandemic.
- The City continued to meet with local business districts to provide additional resources and assistance.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

City Response:

Still addressing the COVID-19 pandemic, the City continued to ensure that residents had access to information and available resources to assist with housing, health and safety concerns. As additional information became available from the Winnebago County Health Department and other financial assistance programs, the City's Neighborhood Specialist consistently communicated with her contact list of over 100 neighborhood groups to ensure that residents across the City was made aware of housing and support services resources. The City also communicated available resources through its website and social media accounts.

The City's Health & Human Services Department works with many private housing providers through the various rental assistance programs and continue to connect with new owners. The department has a long history of working with the local Public Housing agencies-Rockford Housing Authority, Winnebago County Housing Authority/NIREACH (who also covers Boone and Stephenson Counties), and DeKalb Housing Authority. They have partnered for several years with the FUP & VASH vouchers but recently have also received both Mainstream Vouchers and Emergency Housing Vouchers. Through the CES, homeless clients are assisted in completing these applications, helped to get the needed documents.

RHA currently has over 40 Memorandums of Understanding's in place with community and governmental agencies. Collaboration between these agencies, and the City's Health and Human Services Department allowed RHA to assist families to secure financial assistance with utilities, rent, and provide nutritional meals to elderly and disabled families.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

City Response:

The City's Analysis of Impediments to Fair Housing Choice completed for the 2020-2024 Consolidated Plan identified the following impediments to fair housing in Rockford: Fair Housing Education and Outreach, Need for Decent Safe and Affordable Rental Housing, Lack of Affordable Homeownership Opportunities, Need for Accessible Housing Units that are for Sale or Rent and Economic Issues that affect Fair Housing Choice.

Actions Taken to Address Fair Housing Impediments in 2021:

- The City continues to promote fair housing literature and information through its website, as well as make it available in the Community & Economic Development Department lobby.
- The City continued to offer a homebuyer assistance program, which provides assistance to income eligible individuals for the purchase of a home located anywhere within the City municipal boundaries. This program includes individuals who purchase homes through the Rockford Area Habitat for Humanity. All homebuyer participants are required to take a housing counseling class, which is provided by NW HomeStart.
- The City provided a Certificate of Consistency with the Consolidated Plan for various affordable housing developments that applied for IHDA Low Income Housing Tax Credit funds to support their projects.

- The City Council approved \$800,000 to fund a multi-family development (64 units). The award will take place during 2022.
- The City utilized General Funds to support a Citywide Code Enforcement program to identify buildings and properties that have code violations.
- The City continues to offer housing rehabilitation programs to low-moderate income households, including both seniors and those individuals with disabilities. Of the 15 homeowners/homebuyers assisted, seven were elderly (28%).
- The CDBG-CV funds were used to assist microenterprise and sole proprietor businesses who were impacted by COVID-19.
- Economic development staff continue to actively recruit new businesses who can provide additional employment opportunities and work with existing businesses who may need assistance in order to expand their operations.
- The Rockford Housing Authority (RHA) affordable housing developments are distributed across several neighborhoods. However, Housing Choice Vouchers are more concentrated in low opportunity areas. There are some neighborhoods in which there are very few landlords that accept Housing Choice Vouchers or where there are very few affordable rentals available, thereby limiting the housing choices. Through the Move To Work award, RHA will provide landlord incentives to attract landlords with homes within opportunity areas to participate in the HCV program.

CR-40 - Monitoring 91.220 and 91.230

Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements

City Response:

In 2021, the City of Rockford continued its efforts to encourage the use of Minority and Women Business Enterprises (MBEs/WBEs). Outreach activities included the following:

- The promotion and encouragement of minority and women-owned businesses and their participation in the City's procurement process as general contractors, subcontractors, and suppliers of goods and services.
- The City's purchasing staff continued to seek quotes under \$25,000 from Minority- and Women- Owned Businesses that are certified as MBEs/WBEs by the City's Contract and Grant Compliance Officer.
- Businesses certified as MBEs and WBEs are on the City's website for internal purchasers and for the community-at-large to recruit MBEs and WBEs for contracting, subcontracting, products, and services. New MBEs and WBEs are added to this list after the City approves an application that the business owner submits.
- Continued networking with local, state, federal, private agencies, and Rockford Public School District 205, reporting on bid opportunities and organizations to enhance the contractual opportunities for minority and women business development.
- Administered the Procurement Policy approved by City Council that encourages the use of minority- and women-owned businesses in the City's procurement efforts.

The City of Rockford maintains a process for certifying business as MBEs/WBEs, and recognizes certifications from the Illinois Department of Transportation, Illinois Central Management Services, and the City of Chicago as part of this process. As part of bid requirements, each bidder on contracts or commodity purchases and for all road and building construction projects is required to identify each MBE and WBE subcontractor they will use on the contract, including the estimated dollar amount of the subcontract and the percentage to total bid that will be awarded to MBE and WBE subcontractors.

- Tracked MBE/WBE participation of total City of Rockford prime contracts spent in construction services and related supplies during 2021 was \$580,108, representing 67% of total dollars, to MBE/WBE certified businesses. The tracked funds include any contracts awarded by City Council for construction services or materials contracts with a value of over \$25,000.

Events and meetings were limited due to COVID 19 restrictions. However, the City continued to engage with the following businesses: Northwestern Illinois Building Trades, RAMM (Rockford Association for Minority Management), SWIFTT (South West Ideas for Today and Tomorrow), Illinois Tollway Technical Assistance, SBDC (Illinois Small Business Development Center), and the Rockford Regional Hispanic Chamber of Commerce.

Since 2014, the City of Rockford has utilized the LCPtracker System for general contractors and subcontractors to report their certified payrolls for HUD, CDBG, EPA, and other federal government projects that need to report wages under the Davis Bacon Act regulations. In 2020, the State of Illinois implemented an online portal for the tracking of Illinois prevailing wage jobs.

Long-Term Monitoring and Compliance

Monitoring of the CDBG and HOME programs is carried out primarily by the Community Development Compliance staff, with assistance from other Neighborhood Development, Economic Development, Legal, Human Services and Finance staff of the City of Rockford. The level and frequency of monitoring is determined by the specific program or development agreement. Due diligence is conducted by various staff members before any funds are disbursed. HOME and CDBG activities are monitored by assigned staff to ensure that all projects meet housing code compliance and program compliance. Funding for the activities was disbursed incrementally, and each disbursement request was reviewed by a Housing Rehabilitation Specialist to ensure that the federal funds were adjudicated properly, per the program and agreement. Once the rehabilitation was complete and all activity funds had been disbursed, compliance and monitoring of the agreement was the responsibility of the Compliance unit. The Community Development Grants Compliance Supervisor ensured that all occupancy, maintenance, and other requirements for the rehabilitation programs were met. The Compliance staff also monitored IDIS reports on a weekly basis to ensure that funds were being expended in a timely manner. Post-completion monitoring also included reviews of annual reports submitted for rental projects.

In 2021, Neighborhood Development staff continued to make appropriate revisions to program policy and procedures. HOME and CDBG long-term compliance is monitored by the Community Development Compliance Department through a set of spreadsheets and calendar tickler reminders on applicable projects. The City requires all homeowners who receive CDBG or HOME funds to list the City as a loss payee, so that the City is notified if insurance policies are cancelled. In addition, each year a privacy notice is sent out to each homeowner who is still within the term of affordability. This insures notification if a CDBG/HOME participant no longer lives at the property as their primary residence.

Human Services housing staff ensure that the federal funds are being allocated properly, per the program regulations. Once responses to the City Request for Proposal are received, housing staff review the applications and ensure that all applications meet the HUD regulation standard. The applications are then reviewed by a committee comprised of housing staff and Continuum of Care (CoC) members. A recommendation is

then made to the CoC Board. Following CoC Board review, a formal recommendation is made to City Council. ESG recipient costs are scrutinized monthly by both program and fiscal staff to ensure appropriate, eligible expenditures are being made. In addition, monitoring of projects is conducted annually with year one being a full review and year two being a desk review. However, during 2020, all monitoring was desktop due to COVID. The city utilizes the HUD monitoring guides as templates for monitoring sub recipients. Sub recipients receive written feedback consistently throughout the process and at the end of monitoring. They are provided technical assistance to help them overcome any monitoring deficiencies.

Citizen Participation Plan 91.105(d); 91.115(d)

Describe the efforts to provide citizens with reasonable notice and an opportunity to comment on performance reports.

City Response:

A public notice regarding availability of the 2021 CAPER for public review and comment was published in the Rockford Register Star on May 9, 2022. See attachment, “City of Rockford 2021 CAPER - Citizen Participation” for proof of publication. Community service and housing providers were directly emailed a copy of the public notice.

Copies of the CAPER draft were available on the City of Rockford website (www.rockfordil.gov) and at the following locations:

- The City of Rockford’s Community & Economic Development Department (425 East State Street)
- The City of Rockford’s Health & Human Services Department (612 N Church Street)
- Three branches of the Rockford Public Library, and the (6685 East State Street, 1238 South Winnebago Street, 214 North Church Street)
- The Rockford Housing Authority Administration (223 South Winnebago Street).

The CAPER draft was available for public comment from May 10, 2022 through May 24, 2022. This meets the 15-day requirement of 24 CRF Part 91.105(d).

No comments were received from the public.

CR-45 - CDBG 91.520(c)

Specify the nature of, and reasons for, any changes in the jurisdiction's program objectives and indications of how the jurisdiction would change its programs as a result of its experiences.

City Response:

The City's 2020-2024 Consolidated Plan identified six priorities: Housing, Homeless, Other Special Needs, Community Development, Economic Development and Administration/Planning/Management. All of these strategies are identified as a high priority, except for Other Special Needs, which is considered a low priority. These priorities have not changed and are not expected to change during the immediate future.

Throughout 2021, some challenges encountered while administering the City's housing programs included but were not limited to the following:

- The COVID-19 pandemic infected contractors, sub-contractors, and/or homeowners delaying the process for housing rehabilitation programs. In addition, the cost of construction materials continue to fluctuate and are often on backorder.
- Combining other funding sources with the City's CPD program funding requires additional time to underwrite and assist homeowners through local rehabilitation programs. There tends to be more requirements for the homeowners to meet. City staff must document income two ways, one way for the CPD program and another for the other funding source. Separate bidding, agreements, and reporting systems are generally required. In addition, delays may occur because the other funding agencies require review and approval before moving forward.
- The Environmental Review process requires the City to consult with the Illinois Historic Preservation Agency (IHPA) State Historic Preservation Office (SHPO). Although regulations allow for the City to proceed after 30 days without a response from the SHPO. The statewide financing agency, one of the City's funders for the housing rehabilitation program did not. Unfortunately, the SHPO had delays up to 60 days for responses during 2021.
- 78% of the homes in Rockford were built before 1978. The threshold for addressing lead based paint has not changed since the inception of the lead based paint regulations. Full abatement is required for hard costs exceeding \$25,000. It is difficult to bring older housing stock up to code for less than that.
- The cost of rehabilitation on older housing stock can easily exceed \$25,000. Add the cost of lead abatement, and you can easily spend more than the fair market value of the property.
- Some populations that the City serves found it difficult to apply for funding online.
- During 2021, the City denied over 75% of the housing rehabilitation applicants due to the homeowners not meeting requirements explained in the marketing materials. Some denials reasons included, but were not limited to the following: people applying when they

lived outside of the program limits, people not willing to provide the supporting documentation to demonstrate that they qualify for assistance, people withdrawing for reasons unknown, being located in a flood zone, people applying for multi-family buildings when the program is for single family detached homes, and people having open loans with the City and or other agencies that are providing funds.

- CDBG-CV funded the City's microenterprise program. Small businesses are often homebased making it difficult document eligible working capital expenses.

The City continuously looks for ways to administer programming more efficiently. Therefore, the City will continue to do the following:

- Apply for competitive grants to supplement its CPD funds for local programming.
- Collaborate with other agencies serving the same populations
- In 2021, the City implemented Neighborly, a new software system to streamline the application process and reporting. City staff will continue to become more efficient as they familiarize themselves with the system. In addition, City staff will utilize Neighborly support to ensure that Neighborly is being used to its fullest capacity.
- The City provided alternatives for populations having a difficult time submitting applications online. However, City staff may implement more alternatives such as providing how to videos, etc.
- Encourage contractors to become lead certified/licensed contractors, and therefore, increasing the number of contractors bidding on rehabilitation activities.
- Research ways to implement a fee to avoid frivolous applications.
- Enhance marketing to ensure homeowners understand the program requirements.
- Ensuring that one of the qualifications for a Microenterprise Business to qualify, the business must be housed in a physical brick and mortar commercial location.

City Response:

The City of Rockford has one HOME funded rental development that requires on-site inspections. Bridge Rockford Alliance owns 533 Fisher. On-site inspections take place every three (3) years. The next inspection was required to take place during January 2021. However, a pandemic waiver allowed for this inspection to be postponed until 2022.

The CR-40 details long term monitoring for rental developments. Although an inspection was not required during 2021, the owner certified that the property meets local code with their annual report submission. The annual report included, but was not limited to the development proforma documenting continued viability of the project, tenant incomes, and rents.

Provide an assessment of the jurisdiction's affirmative marketing actions for HOME units. 92.351(b)

City Response:

24 CFR Part 92.351(b), requires the City to have procedures to establish and oversee a minority outreach program to ensure the inclusion, to the maximum extent possible, of minorities and women, and entities owned by minorities and women, including, without limitation, real estate firms, construction firms, appraisal firms, management firms, financial institutions, investment banking firms, underwriters, accountants, and providers of legal services, in all HOME funded contracts. The City has a Contract & Grant Compliance Officer and an ED & Diversity Procurement Coordinator (ED Coordinator) to ensure these requirements are met. See Section CR-40 for minority business outreach efforts, regardless of funding source, completed by the ED Coordinator during 2021.

In addition to the ED Coordinator efforts, the City also has an affirmative marketing policy for City staff, sub-recipients, developers, owners, and

sponsors to follow for marketing and minority outreach. It includes a reference to the City's Minority and Women Business Enterprise Procurement Policy that was revised and approved by City Council as ordinance 2019-155-O on July 3, 2019. It states the following:

Statement of Policy: The City of Rockford is committed to ensuring nondiscrimination in the award of City contracts and the participation of certified Minority and Women Business Enterprises (MWBEs) in its procurement of commodities and services. The City will work to remove barriers to the full participation of MWBEs in the award of such contracts by taking a proactive role in facilitating the development and certification of such businesses and enforcing compliance with all local, state, and federal nondiscrimination and equal employment opportunities statutes, as well as this policy.

Policy Objectives: To ensure full implementation of and compliance with this policy, the City will:

- A. Establish a local program for certifying minority – and women-owned business enterprises as those entities are defined in this policy.
- B. Establish proactive policies and procedures that promote full participation by MWBEs in bidding on all City procurement offerings and requests for proposals, including procedures to identify and mitigate or eliminate obstacles to MWBE participation.
- C. Establish and enforce procurement policies and procedures that support participation in City procurement offerings by business entities whose subcontracting practices are non-discriminatory.
- D. Establish annual MWBE utilization goals commencing one (1) year from the adoption of this policy, based upon data collected in previous years(s). These goals shall be aspirational and shall serve only as a measure of the effectiveness of this Policy; goals shall not be imposed upon any individual contract or subcontract.

City Response:

HOME Program Income (PI) received during 2020 is required to be obligated prior to 2021 HOME Entitlement. 2020 HOME PI in the amount of \$7,742.50 was not obligated to a HOME activity within the 2020 Program Year. HOME PI received during 2021 totaled \$15,456.26 and is anticipated to be obligated to an activity prior to 2021 HOME Entitlement being obligated. Therefore, the number of projects and owner or

tenant characteristics for HOME PI are not yet known.

Describe other actions taken to foster and maintain affordable housing. 91.220(k) (STATES ONLY: Including the coordination of LIHTC with the development of affordable housing). 91.320(j)

City Response:

In addition to actions mentioned under Section CR-35 (actions taken to overcome the effects of any impediments in the AI), City staff, developers, and subrecipients follow the City's Affirmatively Further Fair Housing Marketing & Minority Outreach Guidelines and Requirements when marketing affordable housing programs and/or projects. Besides providing a list of all the protected classes as mentioned in federal and state law, the guidance addresses marketing and monitoring. This includes, but is not limited to providing access to the Equal Housing Opportunity logo required for marketing materials, referencing the City's Minority and Women Business Enterprise Procurement Policy, and providing additional resources.

According to the US Census Bureau 2020 American Community Survey 1-Year Estimates, Rockford's racial demographics consists of approximately 70.4% White, and 25.3% Black. Approximately, 18.3% of the Rockford population is Hispanic or Latino (of any race). See Section CR-10 for Racial and Ethnic composition of families assisted through the HOME and CDBG program. Comparatively, of households assisted through the CDBG program, approximately 71% were white, and 29% were Black/African American. Approximately, 14% of households were Hispanic or Latino (of any race). Comparatively, of households assisted through the HOME program, approximately 50% were Black/African American, and 50% were White.

In 2021, City staff participated in the Housing Partnership Group monthly meetings and events facilitated by NW HomeStart, a local HUD certified housing counseling agency and Neighborworks affiliate. This group of local neighborhood and housing non-profits and government agencies meet monthly to share program updates, provide referrals, and discuss how to foster and maintain affordable housing.

Rockford Housing Authority in regards to public housing:

Due to the insufficient affordable housing to meet the demand, residents face limited choices when locating and securing housing. There is a need for more permanent supportive housing for homeless individuals, as well as more housing for extremely low income, low income, and moderate-income residents. Because of this, RHA through its non-profit, Bridge Rockford, has drafted a redevelopment plan that will provide more than 100 homes, within opportunity areas over the next several years. To date, Bridge Rockford Alliance has secured four homes and is in

the midst of rehabbing these homes. Once completed, these homes will become Projected Based (PBV) homes for those who are in need of affordable housing.
