New Business

February Call Volume and Answering Reports – No Comments

Shawn Connors referring to the date 1/25 asked how long the line was down. Director Jen Fey advised 4 hours. Ms. Fey also stated that the outage covered entire northern Illinois.

CAD GIS Quotes

911 Business Mgr John Girone advised that in October the ETSB was presented with the issue of GIS cleanup and routing maintenance for CAD along with a quote in the amount of \$101K. At that time the ETSB asked for an RFP. Today Girone presented two additional quotes from Central Square and Intrado. Girone advised that he had internal discussions with both 911 Directors (Elizabeth Russell and Jen Fey) He noted that Intrado prepares the system for NENA NG standards. Datamark would be a straight line to Central Square, with Intrado John would be the go between. Carla Redd thanked John Girone for the additional quotes.

Nationwide Quotes

John Girone informed ETSB members that capacitors were due for replacement on both UPS systems at County and City 911 Centers. This would get both units through until the entire system will need total replacement. The quote for the county was \$7,732.74 and the city was \$7,402.74. A motion was made to approve the maintenance needed by Nationwide for both centers by Todd Stockburger and seconded by Dave Loria. A vote had begun for each quote but Attorney John Kelly advised that a roll call vote was required for all purchases, regardless of the amount. Co-Chair called for a roll call vote:

National Public Safety Telecommunicators Week

John Kelly advised that currently there are over 7,000 bills. The Senate wasn't in/the House was there. As far as 911 there were a couple bills regarding Tax break and Mental health. Also a discussion seeking increase in surcharge. 911 Goes to Springfield is April 29, 2025. There is some concern regarding a decrease in surcharge monies. The State has no explanation as the why. John Girone stated there was a decrease in Winnebago County's as well. The State is looking into it. Cook County had surcharge checks stolen.
